## Indemnity Bond

(Text of indemnity bond to be executed on non-judicial Bond paper at the time of admission)

### AGREEMENT

Schooling is collaboration between the school and the family in developing a child to his/her full potential. School as an expert body, particularly a boarding school that SelaQui International School is, understands the imperatives of education and child development and hence has built conventions, rules, practices, and as amended from time to time, to enhance and promote the learning and development of all its students.

These rules, instructions, practices are built with a view to promote general wellbeing of the larger community of learners at SelaQui campus and it is possible that individual interests may have to be forsaken for the wider interests of the learning community.

The covenants of this agreement/indemnity bond are accordingly defined and parents are expected to support and cooperate with the school in every possible manner.

This agreement therefore, puts down briefly the responsibilities of the parents or guardians of the students admitted to SelaQui International School, Dehradun.

2. Whereas \_\_\_\_\_ Admission No. \_\_\_\_\_ son/daughter/ward of the Parent and has, at the request of the Parent, been selected for admission to the School for the purpose of receiving education inter alia, on the terms and conditions hereinafter appearing.

3. Now it is hereby agreed by and between the parties hereto as follows:

a) That in consideration of the student being admitted by the School for the purpose of the aforesaid education at the request of the Parent, he/she the Parent, covenants with the School that the student will attend SelaQui International School, Selakui regularly and will observe and comply with all the rules and regulations thereof for the prescribed period, and that he/she, the Parent shall pay to the School regularly and promptly and whenever called upon to do so, all the fees and other costs, as prescribed.

b) That the placing of students in different classes will be at the sole discretion of the Headmaster, SelaQui International School, Selakui.

- c) That the Headmaster can, at any time in the interest of the school, have the student removed if in the Headmaster's sole discretion, the student has failed to accept the discipline of the school and his/her continued presence is detrimental to the interest of the other students and/or the students fails to come up to the academic standard of his/her class and when detention in the same class would make the student too old for his/her class.
- d) That no fees, partial or full, will be refunded if the said student is required to leave the school during term time for any reasons whatsoever.
- e) That the school insists on all students except those exempted, to take part in all the outdoor activities the school has to offer including Sports, Riding Trekking, Camping, Cycling etc. and that the School will not be liable for any damages/charges on account of injuries, fatal or otherwise, which may be sustained by the student, at any time during his/her stay in school, while taking part in studies, sports and extracurricular or any other form of activity of the school.
- f) The Parent hereby agrees to indemnify the School for any loss caused to the school or its property or to its people by the ward, as determined by the Headmaster.
- g) The Parent agrees to settle the dues and outstanding bills if any at the end of the academic years or at the time of the ward leaving the School and it is further agreed that the School has the right of lien over the testimonials and other certificates till the dues/outstanding bills by the School.
- h) The Parent has read the prospectus of the school and other related documents and confirms to that the rules, instructions, covenants contained therein are fully understood by the parent and the parent so undertakes to abide by the provisions so set forth in prospectus applicable for the year of admission and as amended subsequently from time to time.
